ON-LINE

BY MAIL

1. Complete this form. Be sure the correct owner, street address, and pet description(s) appear on all applications.
2. Use this form to register 1 to 5 dogs. Ohio law requires a license for every dog more than 3 months old.
3. **December 1st - January 31st, licensing rate for a one year tag is \$15.00 per dog.** Enclose a check or money order for the correct fees payable to: **Geauga County Auditor**. Please do not send cash. Your application cannot be processed without the correct fees. Statutory late penalty increases the licensing rate to **\$30.00 per dog AFTER January 31st**.
4. Please return the application and a check or money order in the enclosed return envelope. A receipt will be returned to you with your 2026 license tag(s).

IN PERSON

You may purchase the tag(s) in person at any vendors listed on the back. Please bring the attached form when purchasing tags. Exact cash, checks, and money orders are accepted. No credit or debit cards. **VENDORS ONLY HAVE 1 YEAR TAGS AVAILABLE FOR SALE.**

THREE YEAR TAG

December 1st - January 31st, the license rate is \$45.00 per dog. The tag is non-refundable and cannot be transferred to a different dog.

LIFETIME TAG

December 1st - January 31st, the license rate is \$150.00 per dog. The tag is non-refundable and cannot be transferred to a different dog.
