## INSTRUCTIONS FOR LAWRENCE COUNTY KENNEL LICENSES:

ORC 955.01 defines a KENNEL as an establishment that keeps, houses, and maintains adult dogs for the purpose of breeding the dogs for a fee or other consideration received through a sale, exchange, or lease and that is not a high volume breeder.

### IN PERSON

1. The numbers reported by breed below should include each dog more than three months of age.
2. The \$80 kennel fee includes five individual dog tags. Each additional tag costs \$1 each.  
**After January 31**, the statutory penalty increases the price of each kennel license to \$160. Processing of the license requires the correct fee.

Tags may be purchased in person at the Lawrence County Auditor's Office (second floor of the Courthouse), 111 S. 4th St., Ironton, OH 45638.

Kennel tags may be purchased on-line at [www.doglicenses.us/OH/Lawrence](http://www.doglicenses.us/OH/Lawrence). Only credit card payments accepted; processing fee applies. To purchase online, you must have a valid Ohio Vendors License.
