INSTRUCTIONS FOR MORGAN COUNTY KENNEL LICENSES:

ORC 955.01 defines a KENNEL as an establishment that keeps, houses, and maintains adult dogs for the purpose of breeding the dogs for a fee or other consideration received through a sale, exchange, or lease and that is not a high volume breeder.

BY MAIL

1. Complete this form. Be sure the correct kennel owner and street address appear on all applications.
2. List the breeds kept, along with the number of males and females over 3 months of age for each breed.
3. Enclose a check or money order for the correct fees payable to: **Morgan County Auditor**. Please do not send cash. **Before February 28**, licensing rate is \$70.00 for the first 5 tags and \$1.00 for each additional tag. **After February 28**, statutory late penalty increases the licensing rate to \$140.00 for the first 5 tags. Your application cannot be processed without the correct fees.
4. Please return the application, check or money order, and a self-addressed stamped envelope to the Morgan County Auditor's Office, 155 E. Main Street, Rm 217, McConnelsville. A receipt will be returned to you with your 2026 license tag(s).

IN PERSON

Kennel Tags may be purchased in person at the Morgan County Auditor's Office.
Please bring the attached form when purchasing tags.

Certificates of registration and registration tags shall be valid only during the CALENDAR YEAR or YEARS for which they are issued. ORC Sec 955.09.
